**Re: The compliance of Fabricated Extrusion Company's products for the directives of European Reduction of Hazardous Substances, RoHS 10 and the REACH 233 item list of SVHC dated January, 2023 and TSCA, Persistent Bioaccumulative toxins.**

RoHS 10 -Restriction on the use of Lead, Mercury, Cadmium, Hexavalent Chromium, Polybrominated biphenyl (PBB), Polybrominated diphenyl ether (PBDE), Bis(2-Ethylhexyl) phthalate (DEHP), Benzyl butyl phthalate (BBP), Dibutyl phthalate (DBP) & Diisobutyl phthalate (DIBP).

To whom it may concern,

We have completed an evaluation of compounds and raw materials that we use in the processing of your finished goods. Based on the information provided to Fabricated Extrusion Company from our suppliers, we have found that compounds used do not contain any of the above listed restricted substances. In addition, we further confirm that the products are free of phthalates DEHP, DBP, BBP and DIBP.

Regarding TSCA PERSISTENT BIOACCUMULATIVE TOXIC – PBT,

We are pleased to provide the following information concerning the absence or presence of certain substances in product supplied

- Decabromodiphenyl ether (DecaBDE) (CAS no. 1163-19-5)
- Phenol, isopropylated phosphate (3:1) (PIP (3:1)) (CAS no. 68937-41-7)
- 2,4,6-Tris(tert-butyl)phenol (2,4,6-TTBP) (CAS no. 732-26-3)
- Hexachlorobutadiene (HCBd) (CAS no. 87-68-3)
- Pentachlorothiophenol (PCTP) (CAS no. 133-49-3)

are not intentionally used by our suppliers in this product.

Although this product is not routinely tested for their presence, based on product composition knowledge these substances are not expected to be present. However, the fact that these substances are not intentionally used by our suppliers in their product does not exclude that trace levels of these substances may be present as a result of the specific characteristics of the raw materials and/or of the manufacturing process.

Regarding REACH, we see no reason why any substance within the compounds used to manufacture your parts would release out of the finished part. Based on this we would be exempt from registering. We have been in contact with our suppliers, many of whom are registering their substances. In addition, we do not test or analyze for raw ingredients, SVHC (substances of very high concern) as listed in article 57 of REACH. We have discussed this list with our suppliers and to the best of our knowledge none of those substances listed are found in any raw materials used. Since none of these substances are intentionally added they are not expected to be present at levels above 0.1% by weight per separable part of product.

We hope this information is of value to you.
